

“Gameloft Podcast Holiday Contest” Official Rules

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. “Gameloft Podcast Holiday Contest” (“Contest”) will begin at 03:00pm Greenwich Meridian Time (“GMT”) on December 13, 2010 and end at 11:59pm GMT on December 23, 2010 (“Gameloft Podcast Holiday Contest Period”). Contest is sponsored by Gameloft Inc. (“Sponsor”).

- c. Post a video comment in response to this video. The video must be made by participant and feature his Holiday cheers and greetings related to Gameloft.
- d. If participant comments the video with video response and if the video features a Holiday greeting related to Gameloft, the participant enters the contest.
- e. Winner of the contest will be chosen by Sponsor.
