

“Let’s Golf 3” Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. “Let’s Golf 3 Sweepstakes” (“Sweepstakes”) will begin at 10:00am Eastern Standard Time (“EST”) on August 11, 2011 and end at 09:59pm EST on August 22, 2011 (“Sweepstakes Period”). The tweets that do not follow www.twitter.com/gameloft will not be eligible to participate in the Sweepstakes. Each entrant may submit one entry through Twitter during the Sweepstakes Period. Any attempt by any person to enter more than one entry by using multiple/different email addresses, identities, registrations, or any other methods will void all entries entered by that person and that person, at the sole discretion of Sponsors, may be disqualified from the Sweepstakes.
