

“Modern Combat 2: Black Pegasus Facebook sweepstakes” Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. “Modern Combat 2: Black Pegasus Facebook sweepstakes” (“Sweepstakes”) will begin at 05:00pm Greenwich Meridian Time (“GMT”) on September 20, 2010 and end at 05:00pm GMT on October 7, 2010 (the “Sweepstakes Period”). Sweepstakes is sponsored by Gameloft Inc. (“Sponsor”).

To Enter the sweepstakes

1) Facebook

Become a fan of Gameloft’s profile on Facebook.com at <http://www.facebook.com/gameloft>. If you do not have an account on Facebook, you must create one by following instructions on Facebook.com. Creating an account is free.

- a. Once logged in, go to <http://www.facebook.com/gameloft>.
- b. Go on the “Modern Combat 2: Black Pegasus” tab.
- c. Click on the “Like” button to become a fan of sweepstakes profile and enter the sweepstakes.
- d. Each entrant may submit only one entry through Facebook.
- e. The odds of winning will depend on the total number of eligible entries received. Winner will be notified by telephone, email and/or mail. Upon initial notification and verification of potential Grand Prize winner, confirmation will be sent to the winner in writing via e-mail. If there is an insufficient number of entries, Sponsor reserves the right not to award all the prizes. Judges' decisions in all matters relating to this Sweepstakes are final.
