

“Modern Combat 2: Black Pegasus Twitter sweepstakes” Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. “Modern Combat 2: Black Pegasus Twitter sweepstakes” (“Sweepstakes”) will begin at 05:00pm Greenwich Meridian Time (“GMT”) on September 20, 2010 and end at 05:00pm GMT on October 7, 2010 (the “Sweepstakes Period”). Sweepstakes is sponsored by Gameloft Inc. (“Sponsor”).
