

“Shrek Forever After: The Game” Sweepstakes 2 Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. “Shrek Forever After: The Game sweepstakes 2” (“Sweepstakes”) will begin at 12:00am Eastern Standard Time (“EST”) on June 24th, 2010 and end at 11:59pm EST on July 8th, 2010 (“Sweepstakes Period”). Sweepstakes is sponsored by Gameloft Inc. (“Sponsor”).

Eligibility: Sweepstakes is open only to individuals (excluding residents of the province of Quebec in Canada, Cuba, Iran, Syria, North Korea, Italy, Myanmar (formerly Burma) and Sudan and any other jurisdiction where the Contest would be prohibited by law) who are at least thirteen (13) years old at the time of entry, who have an existing Internet connection and who did not purchase any products, services or equipment for the purposes of entering this Contest. To Enter:

- 1) Follow us on Twitter at <http://twitter.com/gameloft> If you do not have an account on Twitter, you must create one by following instructions on Twitter.com. Creating an account is free. Once logged in, go to <http://twitter.com/gameloft>, and follow this profile. Drawing and Notification: Winners will be selected from all eligible entries received in a random drawing on or about July 19th, 2010. One (1) Grand Prize winner will be selected from all entries received during the Sweepstakes Period. Fifteen (15) First Prize winners will be selected from all entries received during the Sweepstakes Period. Twenty (20) Second Prize winners will be selected from all entries received during the Sweepstakes Period. An entry will be deemed to be received on the date an entrant fills out the online entry form or the date a postcard is postmarked. The odds of winning will depend on the total number of eligible entries received. Winners will be notified by telephone, email and/or mail. Upon initial notification and verification of potential Grand Prize winner, confirmation will be sent to the winner in writing via e-mail. If there is an insufficient number of entries, Sponsor reserves the right not to award all the prizes. Judges' decisions in all matters relating to this Sweepstakes are final.
