

## **“Prize Ride 3” Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Prize Ride 3 Sweepstakes" ("Sweepstakes") will begin at 08:00 a.m. GMT on September 19<sup>th</sup> and end at 08:00 a.m. GMT on September, 26<sup>th</sup>, 2013 ("Sweepstakes Period"). To enter the Sweepstakes, name the car with the highest speed in Asphalt 8: Airborne. Comment under the post to receive one entry into the Sweepstakes. Each entrant may submit only one entry during the Sweepstakes Period.
