"GT Racing contest" Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. "GT Racing contest" ("Contest") will begin at 12:00am Greenwich Meridian Time ("GMT") on March 10, 2011 and end at 11:59pm GMT on March 17, 2010 ("Contest Period"). Contest is sponsored by Gameloft Inc. ("Sponsor").
