

“GT Racing contest” Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. “GT Racing contest” (“Contest”) will begin at 12:00am Greenwich Meridian Time (“GMT”) on March 10, 2011 and end at 11:59pm GMT on March 17, 2011 (“Contest Period”). Contest is sponsored by Gameloft Inc. (“Sponsor”).

Eligibility: Contest is open only to individuals (excluding residents of the province of Quebec in Canada, Cuba, Italy, Iran, Syria, North Korea, Myanmar (formerly Burma) and Sudan and any other jurisdiction where the Contest would be prohibited by law) who are at least thirteen (13) years of age or older, as of March 10, 2011, except employees (and immediate family members spouse and children, parents, in-laws and siblings and spouses of the foregoing or anyone living in households of such employees) of Sponsor, its parent, subsidiaries, affiliates and its advertising, sweepstakes or promotion agencies, and any other entity engaged in any way in the development, production, printing, distribution or execution of this Contest (collectively, the “Contest Entities”). To Enter the contest: Become a fan of Gameloft’s profile on Facebook.com at <http://www.facebook.com/gameloft>. If you do not have an account on Facebook, you must create one by following instructions on Facebook.com. Creating an account is free.

- a. Once logged in, go to <http://www.facebook.com/gameloft>, and become a fan of this profile.
- b. Once you’re a fan (or if you’re already a Gameloft fan), you can go on the “GT Racing” Tab and enter the GT Racing contest.
- c. You shall find and enter the name of the vehicles reproduced on the “GT Racing” Tab. The model vehicle will change everyday’s. One First Prize winner per day.
- d. Any attempt by any person to enter more than one entry by using multiple/different email addresses, identities, registrations, or any other methods will void all entries entered by that person and that person, at the sole discretion of Sponsor, may be disqualified from the Contest. Use of any automated system or similar devices to participate is prohibited and will result in disqualification.

Contest Entities are not responsible for Internet malfunctions, failures or difficulties of any kind, or for illegible, damaged, lost, late, misdirected, incomplete or postage due mail or entries. Incomplete entries, or those containing incorrect information, will be voided. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Contest Entities reserve the right to disqualify any person or address suspected of submitting fraudulent entries or of tampering with the entry process. All entries become the property of the Contest Entities and will not be returned.

Drawing and Notification: One Winner per day will be selected from all the people who have found the model vehicle name of the vehicle reproduced on “GT Racing” Tab. If there are several good answers, the winners will be selected in a random drawing. One (1) First Prize winner will be selected from all entries received each day during the Contest Period. An entry will be deemed to be received on the date an entrant fills out the online entry form. Winners will be notified by telephone, email and/or mail. Upon initial notification and verification of potential First Prize winner, confirmation will be sent to the winner in writing via e-mail. If there is an insufficient number of entries, Sponsor reserves the right not to award all the prizes. Judges' decisions in all matters relating to this Contest are final.

Prizes: Seven (7) First Prize winners will receive one (1) iTunes gift card (\$15). The First Prize Average Retail Value (ARV) is \$15. Total ARV of Contest: \$105.

Winners and entrants also agree to release, discharge, indemnify and hold harmless the Contest Entities from and against any claims, damages or liability due to any injuries, damages or losses to any person (including death) or property of any kind resulting in whole or in any part, directly or indirectly, from acceptance, possession, use or misuse of any prize offered, or participation in this Contest.
